

PUBLIC NOTICE

QUALITY, SECURITY, ENVIRONMENTAL & SOCIAL (QSES) COMPLIANCE PROGRAMME

To encourage exporters to address concerns of foreign buyers, the Government of Pakistan has announced provision of subsidy to all eligible exporters who obtain following certification in accordance with the terms of the scheme:

- i. ISO-14000 (ii) SA-8000 (iii) HACCP (iv) ISO-17025 (v) WRAP

Applications under the Certification Incentive Programme are invited from manufacturers-exporters interested in availing the incentive for obtaining the above certifications. The subsidy for certifications at Sr. (i), (ii) & (iii) will be Rs. 100,000 (Rupees one hundred thousand only) while for certifications at Sr. (iv) & (v) the incentive will be Rs. 75,000/= (Rupees seventy five thousand only). Applications on the prescribed form may be sent to the following address:

The application forms are available, free of cost, at all regional and sub-regional offices of Trade Development Authority of Pakistan. The form may also be downloaded from TDAP's website: www.tdap.gov.pk

The procedure for receipt of application and release of payment under the programme would be as follows:-

- a. Applicant firm selects an accredited certification agency for the relevant certification programme, finalizes terms and conditions with it and submits application under the incentive programme to TDAP at the address given above.
- b. Evaluation and acceptance of the request by Certification Cell of TDAP
- c. Completion of certification requirements by the applicant firm leading to award of certificate by the certification agency.
- d. Submission of the certificate by applicant company along with relevant documents to the Director (PPI) QSES Cell for release of 50% of the incentive payment for schemes at Sr. (i) (ii) & (iii), (iv) and 100% for Sr. (v) by the Trade Development Authority of Pakistan.
- e. Approval of the application by the QSES Committee.
- f. Release of balance 50% incentive payment for schemes at Sr. (i), (ii), (iii) & (iv) upon production of satisfactory surveillance audit reports by the applicants covering 2nd year of the certification cycle.
